

NOTIFICATION

The Academic Council in its 74th meeting held on 21st July, 2020 based on the recommendations of the Committee constituted to review the Re-Admission Scheme for different programmes, has approved for withdrawal of the Re-Admission Scheme for different programmes including the Scheme of Admission to Management Programmes through Form-3. The above provisions have been removed from the Prospectus for the July 2020 session also. Consequently, the Re-Admission Scheme for Management and other programmes is NOT available for the old students **ALSO**. However, in order to facilitate completion of their programmes up to June 2021 TEE, the old students will be allowed, as a special case, to seek re-admission subject to other eligibility conditions as per the following timeline and complete their programmes.


3) Timeline for Bachelors Degree and Masters Degree programmes including Management Programmes

Important points:

1. The students, whose Maximum Programme Duration is coming to an end in June 21 TEE and onwards, will **NOT** be allowed Readmission/ extension for appearing in TEE. Therefore, such students will be allowed to complete their respective programmes within Maximum Duration of the Programme (without re-admission) **ONLY**.
2. The extension of Re-Admission period granted till now to the students whose maximum duration has come to an end as per column (1) above of the relevant Table will now be restricted to the TEE session as mentioned in column (2) of the same Table.
3. The Regional Centres will give the above information a wide publicity and also inform the affected students through emails and/or SMS. The information may be prominently displayed on the Notice Boards at the Regional Centres and Study Centres also.
4. The Regional Centres may ensure that the above information is widely shared by the Study Centres in all the counselling sessions
5. The information will be placed on IGNOU website prominently and run as a scroll on the IGNOU homepage for a period of six months.
